TERMS & CONDITIONS **Win a trip for two to Macao**

1. This prize draw is open to travel agents, home workers and tour operators that are resident in the UK, Channel Islands, Isle of Man and Republic of Ireland aged 18 years or over who complete and pass at least one of the four modules of the Macao Specialist online training programme between 5 and 29 December 2018, except anyone professionally associated with the draw.
2. Entry, or acceptance of the prize if you are the winner, implies acceptance of these terms and conditions.
3. All agents who successfully complete and pass at least one of the four modules of the Macao Specialist programme, or who are already qualified Macao Specialists, will automatically be entered and there is no need to take any further action. You will receive one prize draw entry for each module completed up to a maximum of 4 entries per person. The decision of the judges is final and no correspondence will be entered into.
4. The Promoter is not responsible for any technical issues (or other) that impede an entrants' entry being submitted correctly and/or in full. The Promoter is not responsible for any changes in e-mail, mailing address and/or telephone numbers provided at time of entering the prize draw.
5. There is one prize of a three-night trip for two people to Macao including:
 - Return economy flights for two between London and Hong Kong.
 - Return ferry transfers for two between Hong Kong/Hong Kong International Airport and Macao.
 - Three-nights' shared accommodation for two including breakfast at the five-star Sofitel Macau at Ponte 16.
 - The three-night prize must be taken between 3 March and 7 November, 2019, on weekdays only (Sunday to Thursday), and is subject to availability. The following exclusion periods apply: 7-27 April 2019, July 2019, August 2019, and Macao, Hong Kong and China public holidays and special events.
