

## **RCL Cruises Limited**

### **Terms and Conditions of fulfilment of Cruise Prize for the 'Royal Reporter' Prize Draw**

1. The prize consists of a complimentary three-night cruise for one person onboard Spectrum of the Seas departing from Shanghai on 3rd June 2019 returning to Shanghai on 6<sup>th</sup> June 2019. The prize includes return regional or international flights and ground transfers if required.
2. Onboard drinks, personal expenses e.g. laundry, Spa, Shore Excursions, Travel Insurance etc. are not included, and are at the winners own expense.
3. Prize includes one Interior or Ocean stateroom (chosen at RCL Cruises' sole discretion) accommodation, meals (excluding specialty dining), selected onboard entertainment, taxes and gratuities.

The winner must contact RCL Cruises within 14 days of the draw in order to arrange their prize fulfilment, failing which the Promoter reserves the right to re-draw the prize.
5. The Promoter shall run the Prize Draw in the TTG travel magazine from 11 April 2019 until 1<sup>st</sup> May 2019, subject to Promoter's published Terms and Conditions of entry.

To enter the Prize Draw, entrants must (i) be a member of the Royal Caribbean Club Rewards program, (ii) make at least one Royal Caribbean booking between 11 April 2019 and 1 May 2019, (iii) submit their qualifying booking via the Club Rewards website ([www.myclubroyal.co.uk](http://www.myclubroyal.co.uk)), and (iv) visit [ttgmedia.com](http://ttgmedia.com) and enter the Prize Draw, including telling the Promoter in 60 words why they think they should be the Royal Reporter onboard the prize cruise.

RCL Cruises' standard booking terms and conditions will apply, save where varied by these terms, in which case these terms shall prevail.
